Information on Admission to K1 Classes in the 2025/26 School Year

Collection of application Forms (No quota):

- 1. Download from school website : <u>http://kinglam-nursery.hklss.hk</u>
- 2. Obtain from school in person

Distribution Period:

- 1. Date: whole year
- 2. Time: 9 a.m. to 12 p.m., 2:00 p.m. to 5:00 p.m. (Mondays to Fridays) / 9 a.m. to 12 p.m. (Saturdays)

Return of Application Forms (No set quota for the kindergarten):

- 1. Period : When the child is twelve months old, parents can submit the application form
- 2. Time : 9:00 a.m. to 12:00 p.m., 2:00 p.m. to 5:00 p.m. (Mondays to Fridays)
 9:00 a.m. to 12:00 p.m. (Saturdays)

3. Return method: Submit the application form in person [together with the documents required (including identity document)]

4. Application fee (if applicable): HK\$40.00 (to be collected together with the application form). The application fee is non-returnable whether the application is successful or not.

Application for the "Registration Certificate for Kindergarten Admission"

1. Under the kindergarten education scheme (Scheme), each child who can receive education in Hong Kong will only be issued a registration document and all Scheme-KGs can only admit students holding a valid registration document.

2. Parents are required to submit an application for the "Registration Certificate for Kindergarten Admission" (hereafter referred to as "RC") to EDB from **September to November 2024.** The "RC" will be open for applications in September 2024 and EDB will announce and upload the details of application onto EDB's website

(https://www.edb.gov.hk/en/edu-system/preprimary-kindergarten/kindergarten-k1admission-arrangements/front.html) in due course. Upon receipt of the applications with all necessary information and documents provided, EDB will generally take six to eight weeks to complete processing of the applications and issue the "RC" to applicants who are eligible for receiving subsidy under the Scheme by post. If a student cannot obtain an "RC" as he/she can receive education in Hong Kong but is not eligible for receiving subsidy under the Scheme 1, EDB will then issue a "Kindergarten Admission Pass" (hereafter referred to as "AP") to the student concerned for registration and admission to a Scheme-KG but the parents concerned are required to pay full school fees before deduction of subsidy under the Scheme as shown on the Fees Certificate of the KG to which the child is admitted.

1 Upon obtaining permission from the Director of Immigration, non-local children (such as children holding a form of recognizance,

children whose parent(s) is/are holding a student visa, etc.) can receive education in Hong Kong but they are not eligible for subsidy under the Scheme.

Admission Criteria

1. Interview performance

2. All children aged from 3 to 6

3. The applicant with sibling(s) currently studying in the kindergarten will be given due priority consideration

4. The applicant from families in need will be given due priority consideration.

5. Same religion (As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place.)

Interview Arrangements

1. The kindergarten will arrange interview for all applicants

- 2. Interviews will be conducted on Dec 2023, the result will be informed by letter
- 3. Individual interviews will be arranged
- 4. Parents should accompany their child for the interview

5. When interviewing non-Chinese speaking children, schools will arrange interpreters or translations for applicants as needed. Parents and children's relatives or friends who can understand Chinese are also accepted for the interview.

Announcement of Admission Results

We will inform parents of the K1 admission results before 13 December 2024 by post. **Registration Arrangements**

1. Successful applicants: Parents should complete the registration procedures for their child from "Centralized Registration Dates" (2^{nd} to 4^{th} January, 2025) by submitting the "RC" / "AP" to the kindergarten and paying the registration fee.

2. Applicants on the waiting list: If a place is available the school will contact the parents by letter. Parents should complete the registration procedures for their child according to the specified date set by the school. Parents are required to submit the "RC" / "AP" to the kindergarten and pay the registration fee.

3. Please be reminded that if parents cannot submit the "RC" / "AP" during registration, the kindergarten may not be able to complete registration for their child. Hence, parents are required to submit application for the registration document to EDB within the specified period.

4. If the child concerned studies in the kindergarten, the registration fee paid will be refunded in the first school month. Should parents decide to choose another school after registration, please notify the kindergarten in writing. The kindergarten will return the "RC" / "AP" but the registration fee will not be refunded. Upon obtaining the "RC" / "AP" by the parents, the kindergarten will no longer reserve a seat for the child.
